SPECIAL TRANSPORTATION IN PRIVATE VEHICLES BY ADULT VOLUNTEERS

As a general rule, it is much preferred that students be transported by the District's school buses. There are occasions, however, where a parent or guardian of a student may wish to transport the student in a private vehicle. In those cases where the student wishes to be transported to and/or from an extracurricular event or field trip by his or her own parent or guardian, the student shall furnish the building administrator with a Request and Release form signed by the parent or guardian prior to the trip. The Request and Release form shall be in the form provided by the District (Form: 753-A).

In the event that a student wishes to take advantage of transportation to be provided by another student's parent or guardian, the parent or guardian of the student *making the request* **and** the parent or guardian of the student who will be *providing the transportation* shall both sign the appropriate form (Form: 753-B).
