342.1

~~The Board of Education shall provide a free and appropriate public education to each child with a disability within its jurisdiction, regardless of the nature or severity of the disability. Educational and other services shall be provided either locally or through agreements with other school districts or agencies and shall be provided in accordance with state and federal law.~~

~~Procedures for screening, referring, identifying and serving children with disabilities shall be consistent with the Wisconsin Department of Public Instruction *Model Local Educational Agency Special Education Policies and Procedures*, which shall be considered as part of the District's Special Education Handbook. The District Special Education Handbook shall be considered Board policy.~~

The School Board recognizes its responsibility to provide a free appropriate public education for all students in the District and directs the District Administrator to provide appropriate programs and services that meet the needs of students with disabilities. The District may contract the Cooperative Educational Service Agency and other public school districts and private schools to provide special education programs and/or services for individual students with disabilities whenever it finds such an option appropriate to the needs of the student and cost-efficient for the District.

Specific educational programs and services for students with disabilities shall be determined by the student's individualized education program (IEP) team and be based on an assessment of the student's individual needs. Students with disabilities shall participate in academic assessments required by law and the District, with or without accommodations, or in alternate assessments as outlined in the student's IEP.

The District Administrator or designee shall complete all special education report forms, audit materials and District plans as may be required by any state or federal agency.
