Breakfast – we knew the breakfast numbers would be going down this year because we moved breakfast from second hour to before school. I was planning on losing about ½ the students. I didn't expect the numbers to be this low.

Lunch – Numbers are so low because of the new menu standards all schools in the nation must follow. We had good numbers the first two days of school then they started to drop. Hopefully they will start going up as students and parents realize the meals served at school follow the guidelines set by the U.S.D.A. for healthy school meals, and exemplify a healthy balanced diet.

High School Report to the Board of Education Mark Weddig 10-3-12

Reading Across the Curriculum:

The high school staff was in-serviced during our PLC meeting the morning of 9-19-12 on techniques to incorporate reading in all classes. This was developed to help us meet our building goals for the year. An extensive list was presented to the group that included a wide variety of "shovel ready" methods help to incorporate reading at PHS.

Bullying Awareness:

The entire 7-12 student body viewed a film "Bully" during the afternoon of 9/26. It was well received and sent a clear message about the ramifications of bullying and harassment. This will be followed up by an activity during Advising on October 8th.

In summation, for the last five years, PHS students have scored near the state average in the ACT, with exception of Math, which is lower by a wider margin, and significantly in 2012. The Ready for College Level Coursework average for the last five year is similar to the average scores, with Math standing out as being noticeably lower.
